AGENDA ITEM NO. 2 Action Item – Approval of Agenda

a) Manager's and Ground's Foreman Report — Manager Carbahal reported the following. Staff had two full burials and one ground cremation burial. The abandoned plots court request has been posted at required areas and in the Winters Express newspaper. Sections 6 & 7 burials have all been written up and ready for computer mapping. Section 2 will follow. She reported a public complaint regarding the dry grass throughout the grounds. Our County representative who processes our claims and deposits is leaving and we will be assigned another representative later. Flag placement on Veterans graves will be placed and the large flags also. The annual planning meeting is scheduled for May 18th. Foreman Glide reported spraying Turflon around headstones, repaired a main water leak in Section #2 and installed a shutoff valve. They

- **b) Budget** The County's general ledger report for March was received with Manager Carbahal adding the cemetery's April numbers. She stated revenues at this time exceed operating expenses by \$155,000.00 but two months of expenses will reduce that amount.
- c) Correspondence The following was received. The first run Notice of our abandoned plot request was received. PCA notifications regarding retirements of managers and upcoming seminars was received. We were notified by CSDA that AB339 has had specific mandates relating to Special Districts removed from the bill requiring Special Districts to provide public participation access with phone, online connection and two-way video and audio for all meetings. We also received sponsorship information from the Wreath Project for Remember a Vet. Trustee Justus commented that he likes the idea of the large wreath placed at the flag pole during December.
- **d) Investment Reports** The Investment Committee reported the following for March 31, 2021. The Endowment Principal account with Stifel is \$267,501.46 and the Endowment Interest is \$104,213.87.
- **e) Board Comments and Future Agenda Items** Board members requested planning meeting have a quick review of last year's wish list. Chair Bristow requested new management be a discussion item each month.
