AGENDA ITEM NO. 2 Action Item - Approval of Agenda

Chair Kilkenny called for a motion to approve. Trustee Justus made the motion to approve the agenda. There was a second from Trustee Bozarth. With no further discussion the motion carried with all ayes.

AGENDA ITEM NO. 3 Public Comments

Chair Kilkenny opened and closed Public comments seeing no public in attendance.

AGENDA ITEM NO. 4 - ACTION ITEMS

- **a) Approval of December Meeting Minutes** Chair Kilkenny called for a motion to approve. Trustee Hague made the motion to approve the meeting minutes as submitted. Vice-chair Bristow seconded the motion. With no further discussion the motion carried with all ayes.
- b) Approval of December Submitted Claims Chair Kilkenny called for a motion. Vice-chair Bristow made the motion to approve the claims submitted. The motion was then seconded by Trustee Bozarth. Trustee Hague asked about the Streamline invoice. Manager Carbahal stated the charges are for web-site management. Vice-chair Bristow inquired if the claim paid to Design Space was the last one for the building. The Manager responded for the building alone, yes. With no further discussion the motion carried with all ayes.

It was seconded by Trustee Justus. With no further discussion the motion carried with all ayes.

Trustee Justus made the motion to retain the current officers in place with Trustee Kilkenny as Chairperson, Trustee Bristow as Vice-chair and Manager Carbahal as Secretary/Board clerk. It was seconded by Trustee Bozarth. With no further discussion the motion carried with all ayes. Manager Carbahal stated she has been advised by both County and CalPERS the Board members should be classified as employees. Chair Kilkenny asked if other cemeteries do the same. Manager Carbahal answered that she knows of cemeteries that do classify Board members as employees. Trustee Justus made a motion to table the topic until next meeting, with a second from Trustee Bozarth. The motion carried with all ayes.

AGENDA ITEM NO. 5 - DISCUSSION ITEMS

- a) Manager's and Ground's Foreman Report The Manager reported the following. Staff had five burials. The County will not be switching payroll companies. Police were called out due to continued graffiti on Cemetery Drive. The Police suggested cameras and lighting. The phone and internet system will be switched from AT&T to Wave and that will save \$1500 per year. The new office is near completion with final inspection to be done on January 14th. Foreman Glide reported that more cement coping around family plots are being uncovered. Trees and shrubs are being trimmed or pruned. Equipment has been serviced and tires were taken to Pisani's for repair. Trustee Justus asked, when can we expect delivery of the excavator. Foreman Glide stated he has not heard and will place a call to see if there's been any change.
- b) Budget Updates The Manager presented the budget with County reports through November and preliminary numbers for December. Nothing has been received for the property tax revenue expected. Burial revenue is up from last year and all other accounts are as expected. Trustee Hague inquired about the dollar amount for the Investment Earnings Pool. Manager Carbahal stated that is an amount that the County is required to show now that we are having complete Audits. The County then charges us for placing that on our Balance Sheet. The Manager added the final retainer payment of \$22,000 for the modular is being held until a final lien release has been received from the contractor's materials supplier.
- **c) Correspondence** The Board members were asked if any would be attending the CAPC meeting in February. CSDA sent out information and was asking for feedback on SB45 and the cost associated with this Climate Bond and how it might impact Special Districts. Manager Carbahal reported a phone call from Sandra Wheeler of Stifel Investments that the final transfers of Endowment money from Wells Fargo Advisors to Stifel Investments has been completed. Reports should be out in a few weeks.
- **d)** Board Comments and Future Agenda Items The Board should be in the new office for February's meeting.
