AGENDA ITEM NO. 3 Approval of Agenda and Public Comments

Chair Bristow called for a motion. Trustee Kilkenny made the motion to approve the agenda. Trustee Justus seconded the motion. With no further discussion the motion carried with all ayes.

Chair Bristow opened public comments, then closed public comments seeing no other public in attendance.

AGENDA ITEM NO. 5 – INFORMATION ITEMS

- a) Well and Grounds Update The Board discussed the timeline for the well and pump. Chair Bristow explained he had received calls related to the condition of the dry grounds and expected those public members in attendance to voice their concerns. As no public showed up the Board discussed ways on how to reduce the concerns the public might have with the continued dry grounds and stressed the need to keep weeds controlled. Manager Carbahal added another well driller had come in and would be available to drill if permit could be transferred. Manager Carbahal voiced concerns that this driller was not registered with the DIR and wouldn't be able to provide proper documentation needed.
- **b) Manager's Report/Grounds Foreman Report** The Manager reported the following. Staff had three full and one cremation burial, three citizen complaints came in prior to release of balloons for the Michael Bazan funeral. Received calls regarding the condition of the dry grounds and a large redwood tree was removed due to disease. The Audit for FYE 2021-2022 is proceeding, abandoned plots processed a year ago has been received. A call was received from Eaton Drilling giving us drilling dates of September 6-12. No word received regarding the Niche designs. Foreman Glide's report stated they continue the ongoing spraying of weeds, watering trees and shrubs. Using the city's fire hydrant to fill water totes has increased efficiency with reducing the time it takes to fill the 250 gallon water totes, therefore they can spend more time watering.
- **c) Current Budget** The Manager presented the budget with final numbers through May and preliminary numbers through June. Revenues exceed appropriations by \$170,000.00. These funds were to have been used towards the drilling of the new well, niches and cement pads. These funds will transfer to the new budget for the same purpose.
- **d)** Correspondence Best, Best & Kreiger Attorneys rate notice increase effective July 1, 2022. Emails received from citizens regarding dry ground conditions.
- e) Investment Report The June report will be discussed next month.
