#### Wednesday, January 13, 2021

The regular scheduled monthly meeting of the Winters Cemetery District was held Wednesday morning, January 13, 2021, 9:00 a.m. at the cemetery office.

#### **ROLL CALL:**

Vice-chair Joseph Bristow called the meeting to order noting the following Board members present and staff in attendance.

Also in attendance Manager Sheila Carbahal and Foreman Nick Glide.

#### AGENDA ITEM NO. 2 Action Item — Approval of Agenda

Vice-chair Bristow called for a motion to approve. Trustee Bozarth made the motion to approve the agenda as written. There was a second from Trustee Hague. With no further discussion the motion carried with all ayes.

#### **AGENDA ITEM NO. 3** Public Comments

Vice-chair Bristow opened and then closed public comments seeing no other public in attendance.

#### **AGENDA ITEM NO. 4 - ACTION ITEMS**

- **a) Approval of December Regular Meeting Minutes** Vice-chair Bristow called for a motion to approve. Trustee Justus made the motion to approve the minutes as submitted. Trustee Bozarth seconded the motion. With no further discussion the motion carried with all ayes.
- **b) Approval of December Submitted Claims** Vice-chair Bristow called for a motion. Trustee Bozarth made the motion to approve the claims submitted, then asked about the claims from Ramos Oil and Eaton Pumps. Manager Carbahal responded Ramos Oil delivered the new fuel tank and gasoline and Eaton Pump replaced the new pump filter. The motion was then seconded by Trustee Hague. With no further discussion the motion carried with all ayes.

- c) Burial Revenues and Certificates Issued Vice-chair Bristow called for a motion. Trustee Justus made the motion to acknowledge the revenues received and the sale of Burial Rights Certificates #1582-1584. Trustee Bozarth seconded the motion. With no further discussion the motion carried with all ayes.
- d) Offer NOV Settlement Offer Manager Carbahal presented the settlement offer of \$881.00 made by the Yolo-Solano Air Quality Management District to settle a fine imposed for improperly using a fuel tank over 240 gallons per their restrictions. Although this requirement was unknown due to the current tank had been purchased in the early 1990's. Vice-chair Bristow called for a motion. Trustee Justus made the motion to reluctantly approve to pay the settlement fine. It was seconded by Trustee Hague. With no further discussion the motion carried with aye votes from Vice-chair Bristow, Trustee Justus and Trustee Hague. A nay vote was voiced by Trustee Bozarth.

**e) Board Member Elections** — Vice-chair Bristow postponed this item until February's meeting noting Manager Carbahal stated official word had not been received from Board of Supervisors on re-appointments of three of our board members.

#### **AGENDA ITEM NO. 5 - DISCUSSION ITEMS**

- a) Manager's and Ground's Foreman Report Manager Carbahal reported the following. Staff had one full and one Niche burial. The 550 gallon fuel tank was removed and replaced with a 240 gallon tank per requirement from the YSAQMD. The County has said they are working diligently to process our claims in a timely fashion in order to avoid late charges from our vendors. Mapping of Section #7 has begun. Foreman Glide reported the following. The crepe myrtle trees have been pruned, leaves mulched, weeding the slope and uncovering more cement copings in the old sections of six and seven. Foreman Glide also reported purchasing a back pack blower.
- **b) Current Budget** The County reports through November were received. Plot and burial sales were the only revenues recorded. Two service and supply accounts are over budget by two hundred dollars. The draft audit will be reviewed before payment of Nigro and Nigro's invoice goes to County for payment.
- **c) Correspondence** Emails were received from CalPERS, CAPC, Best Best and Krieger. The County of Yolo requested a signed acknowledgement regarding our Auditor's name who's preparing the Special District Financial Transaction Report.
- **d) Investment Reports** The Investment Committee will meet and report once December's reports have been received.
- **e) Board Comments and Future Agenda Items** Board member elections will be held in February.
