# WINTERS CEMETERY DISTRICT BOARD OF TRUSTEES MINUTES Wednesday November 13, 2019

The regular scheduled monthly meeting of the Winters Cemetery District was held Wednesday morning, November 13, 2019, 9:00 a.m. at the cemetery office.

### **ROLL CALL:**

Chair Kilkenny called the meeting to order noting all Board members present and staff also in attendance.

### AGENDA ITEM NO. 2 Action Item - Approval of Agenda

Chair Kilkenny called for a motion to approve. Vice-chair Bristow made the motion to approve the agenda. There was a second from Trustee Bozarth. With no further discussion the motion carried with all ayes.

### **AGENDA ITEM NO. 3** Public Comments

Chair Kilkenny opened and closed Public comments seeing no public in attendance.

### **AGENDA ITEM NO. 4 - ACTION ITEMS**

- **a) Approval of October Meeting Minutes** Chair Kilkenny called for a motion to approve. Trustee Hague made the motion to approve the meeting minutes as submitted. Trustee Justus seconded the motion. With no further discussion the motion carried with all ayes.
- **b) Approval of October Submitted Claims** Chair Kilkenny called for a motion. Trustee Justus made the motion to approve the claims submitted. The motion was then seconded by Trustee Bozarth. The Board members commented on the first invoice presented for the modular work site. With no further discussion the motion carried with all ayes.

- **c) Burial Revenues and Certificates Issued** Chair Kilkenny called for a motion. Trustee Justus made the motion to acknowledge the revenues received and the sale of Burial Rights Certificate #1555 issued. It was seconded by Trustee Hague. With no further discussion the motion carried with all ayes.
- d) Resolution #2019-01- Investment Changes Chair Kilkenny stated at last month's meeting the Board discussed the possible withdrawal of Endowment funds from Wells Fargo Advisors to Stifel, Nicolaus & Company. The Investment representative had informed the Board of her decision to move and was requesting the transfer of funds move with her. Chair Kilkenny called for a motion. Trustee Justus made the motion to accept Resolution #2019-01 which transfers Endowment Principal and Interest from Wells Fargo Advisors to Stifel, Nicolaus and Company. It was seconded by Trustee Bozarth. The Board members discussed their confidence in our investment representative and felt confident in the transferring of funds. With no further discussion a Roll call vote was taken. Chair Kilkenny aye, Vice-chair Bristow aye, Trustee Justus aye, Trustee Bozarth aye, Trustee Hague aye. The motion carried unanimously.
