#### Wednesday, January 10, 2024

1. Chairperson Bristow called the meeting to order at 9:00 a.m.

#### 2. ROLL CALL:

**Present:** Chair Joseph Bristow, Vice-chair Timothy Bozarth, Trustee's Larry Justus, Dennis Kilkenny and Viona Hague. Also, in attendance Board Clerk/Manager Sheila Carbahal and Grounds Foreman Nick Glide.

**AGENDA ITEM NO. 3 Approval of Agenda -** Chair Bristow called for a motion to approve the agenda. Trustee Kilkenny made the motion to approve. It was seconded by Vice-chair Bozarth. With no further discussion the motion carried with all ayes.

**AGENDA ITEM NO. 4 PUBLIC COMMENTS** - Chair Bristow opened and then closed public comments seeing no other public in attendance. Trustee Justus commented he wanted to wish Trustee Hague a happy birthday.

#### **AGENDA ITEM NO. 5 CONSENT CALENDAR**

- **a) Approval of December Regular Meeting Minutes** Chair Bristow called for a motion to approve. Trustee Kilkenny made the motion to approve December's regular meeting minutes as submitted. Trustee Justus seconded the motion. With no further discussion the motion carried with all ayes.

Staff had two full burials and two in ground cremation burials. Cement vaults were ordered from Cordeiro. Two benches for the Niche area were ordered. The estimate for the pump enclosure and bollards should be received soon. The Auditor requested more detailed information from the County. The mapping software additions and corrections should be completed soon. Foreman Glide reported all trees were fertilized, leaves are being picked up daily and equipment repairs are being made.

- **b) Current Budget** Manager Carbahal presented the budget with up-to-date reports through November and preliminary numbers through December. She presented the new INFOR Trial Balance and General Ledger Transaction reports. Trustees agreed to continue receiving the excel report and include one of the new INFOR reports.
- **c) Correspondence** The County shared information regarding the staffing changes within Yolo County's Department of Financial Services and who will be our initial contact person. Information from the Office of Emergency Services was received regarding the G-402 course and how to familiarize individuals for supporting incident management when needed.
- **d) Investment Report** The Investment committee will meet following the current meeting.
